



We are delighted to have you as our esteemed member. Please find below the latest updates on the progress of NSR:

- ➤ More than 14.46 lakh Knowledge Professionals in the IT/ITeS & BFSI industry have registered their profiles on NSR website and more than 9.52 lakh professionals have completed their registration by submitting biometrics.
- ➤ Since January 2013 1,26,577 professionals got biometric registered on NSR.

FREQUENTLY ASKED QUESTIONS:

Q1. How do I login to my NSR profile and update my details?

Ans: You can login to your profile by visiting the NSR website https://nationalskillsregistry.com and clicking on link "Already Registered, Access your profile". Kindly <u>Click here</u> to login to your NSR profile. Login and update any changes for your profile details like address, education and present and previous employments. Kindly refer to the "Profile Access Guidance Manual" available in the following link if you have any difficulties. <u>Click here</u> to access the same.

Q2. How do I renew my NSR profile?

Ans: On successful login to your profile the welcome page will indicate the validity period of your profile. Click on the link "Renewal Registration" or "Request for — Renewal Registration" and select the number of years for which you wish to pay the annual fees. You can choose to make online payment and renew your account instantaneously. Alternatively you can click on Payment to POS link and generate bill, take print of the same and make payment at nearest Point of Service (POS) office. Your account will be renewed after upload of the transaction by POS.

Q3. How do I get my profile verified?

Ans: Visit the menu option "Request for – EBC Verification" and select the fields in your profile to be verified and submit. Your request will be allocated to any of the 18 Empanelled Background Checkers on NSR and you are required to make payment and submit documents to the EBC prior to verification. Once verified the information cannot be changed and verification results will be permanently recorded on your profile. Verification will ensure credibility of your profile information and be a value addition to any company which views your profile.

Q4. How do I allow companies to view my profile?

Ans: Kindly visit the menu option "Request for – Permit Companies" in your NSR login to give permission to NSR member companies to view your profile. You can permit maximum 10 companies to view your profile at any point of time and also specify the number of days for which your profile can be viewed by each company.
