# Q1: How to unlock my NSR profile?

**Ans:** Please reset your login password of NSR to unlock your account. <u>click here</u> for the direct link to reset your NSR Login password

#### Q2: How to generate NSR eCard?

**Ans:** Kindly visit the link "Already Registered, Access your profile" on the NSR site and login with your ITPIN, Login Id and Login Password. Go to the menu "Request for – Generate NSR eCard" to view your electronic card. You can take print of the same if required.

## Q3: Can I get my NSR profile verified?

**Ans:** Yes. For your NSR profile to be verified a background check request needs to be submitted for the fields to be verified. You can use the option "**Request For - EBC verification**" in your ITPIN login and submit verification request by ticking the relevant fields in your profile and submitting them for verification. You will be allocated a background checker by the system. The contact details of the background checker are available on <u>https://nationalskillsregistry.com/background-verification.htm</u>. The background checker will inform to you about the total charges to be paid for the verification. After receipt of payment and the necessary documents from you, verification will be commenced and the verification results will be updated against the respective fields in your profile. These fields will then be permanently displayed as verified along with the verification results.

## Q4: How to update previous employment records on NSR?

*Ans:* Kindly login to your NSR profile, use menu option "My Profile – Correct Errors in data" and click on the Modify buttons to navigate to the Employment details section. At the bottom of this screen there is a button called Add Previous Employer. After entering the previous company details, click on the Update button to save the additions made.
