

# "NSR for You" – Ensure to update and complete your Profile


Your NSR profile is your credible view to your current and prospective employer companies and their clients. NSR has provided you the opportunity to right represent you, get verified and credibly recognized; differentiated from those who are faking details. All large IT / ITeS companies have adopted NSR implementation to ensure that over the next 2 -3 years every employee they have and every new hire is registered and verified. Therefore it is important to **keep your profile updated**, **complete** and **ensure accuracy**.

- 1. Have you entered all required details (all qualifications / employments) to your profile while registering?
- 2. Have you shifted from your last address?
- 3. Have you changed jobs or got promoted?
- 4. Have you got any additional qualification?

All you need to do is Login to your NSR profile using your ITPIN (also mentioned in this mail) and your Login credentials (set by you at the time of registration) and update your profile. Welcome Screen: When you Login to your NSR profile following information is presented on the log-in page:	
<ul><li>♣ Your Name as recorded on NSR</li><li>♣ Your Last Login Date and Time</li></ul>	Initiate for background verification of your profile using the main menu "Request For" >> "Background Verification".
♣ Date of validity of your NSR Annual Fee	NSR also enables your existing background check report available with your employer company to be uploaded against your profile.  Makes it transparent to you!!!

### NSR FAQs

### Question: I have changed my job. How do I update the same on my NSR profile?

Ans: You may Login to your NSR profile using your ITPIN and Login credentials set by you at the time of creating your profile. Under the main menu "My Profile", click the sub-option "Change in Employment". The system will ask you to enter the Transaction password (set-up by you during registration) for modification in your profile data. On correctly entering the Transaction password, you will have to enter the relieving date of the present employment mentioned in your profile and fill in details of the company you have joined. Click "update" after you have entered the details. Your NSR profile will be updated with present employment. You may then view your updated profile.
