Question: My Previous employer company is closed. Should I register this?

Ans: You should enter complete and factually correct details on your NSR profile. If details in respect of such employment are verified, the Background verifying agency would find-out that the concerned employer company has stopped operations or is not traceable. Therefore the verification report would indicate that details "Could not be Verified" and reasons for the same.
